

MEMORANDUM OF AGREEMENT
BETWEEN
FACULTY OF MEDICINE, UDAYANA UNIVERSITY, BALI, INDONESIA
AND
COLLEGE OF MEDICINE, NATIONAL CHENG KUNG UNIVERSITY, TAIWAN

1. Preamble

In accordance with the mutual desire to foster cooperation between College of Medicine, National Cheng Kung University (“CM_NCKU”) and Faculty of Medicine, Udayana University (“FK_UNUD”), and in order to explore the potential for dual degree programs set out below, the two institutions have signed the following Memorandum of Agreement.

2. Potential collaboration for dual degree programs

Based on the principles of mutual benefit, both institutions intend to explore opportunities for:

- (a) Dual Bachelor's and Master's degree program described in appendix 1-1.
- (b) Dual Master's degree program described in appendix 2-1.
- (c) Dual Master's and Ph.D. degree program described in appendix 3-1.
- (d) Dual Ph. D. degree program described in appendix 4-1.

3. Implementation of Memorandum

Both institutions agree that the specific dual degree programs shall be developed for implementation of this Memorandum based on discussions and negotiations between two institutions. Agreement of contracts shall be signed separately to carry out these dual degree programs.

Both institutions agree that all financial arrangements shall be determined on the basis of specific dual degree programs, and will depend on the availability of the funds. This Memorandum of Agreement shall become effective for a period of 5 year upon the date of signature by the representatives of the two institutions, and shall be renewed by mutual consent.

If this MoA has been drafted in more than one language, the English version shall control in the event of inconsistency in meaning or interpretation of terms.

Agreement on Dual Bachelor's/ Master's Degree Program
between
College of Medicine, National Cheng Kung University
and
Faculty of Medicine, Udayana University

Preamble

In accordance with the mutual desire to foster cooperation between College of Medicine, National Cheng Kung University ("CM_NCKU") and Faculty of Medicine, Udayana University ("FK_UNUD"), and in order to promote research collaboration as well as to explore the Dual Bachelor's/Master's Degree Program ("Program"), which may include faculty exchange and student exchange, the two institutions hereby agree with the following terms under this agreement.

Article 1: Definitions

1. "Home University" shall mean the university in which the students are originally enrolled.
2. "Host University" shall mean the university that has agreed to receive the Program students from the home university.

Article 2: Overview

Successful Program students will be awarded a Bachelor's degree by the home university, FK_UNUD, and a Master's degree by the host university, CM_NCKU, in a minimum of five years in total. Eligible candidates are enrolled students in an undergraduate program at the home university and, in the 4th year, through proper application procedures, they will come to CM_NCKU as exchange student. Student must then return to FK_UNUD to complete the degree requirements at the home university. After receiving the Bachelor's degree from home university, student will then enter CM_NCKU as a master degree student through proper application and complete the requirements at the host university in order to receive Master's degree awarded by the host university.

Article 3: Requirements for an undergraduate candidate

1. Participating students must be full-time enrolled students in an undergraduate program at the home university.
2. Participating students shall spend at least three years in an undergraduate program and complete the credit hours and specific courses required to earn the bachelor degree at the home university. Credits obtained at the host university can be considered for accreditation at the home university. Upon completing the specified courses and fulfilling total credit hours requirements, successful students will be awarded a bachelor degree from the home university, usually at the end of the fourth year. The graduation requirement for the bachelor degree is decided by the home university.

3. The home university will pass their applicants' data and application materials to the host university in order for the host university to handle necessary admission procedures.

Article 4: Tuition, Fees, and Number of students

1. Each university will endeavour to ensure that outgoing students are properly prepared for their overseas experience in academic matters and appropriated matters of health, language, local custom etc.
2. Participating 4th year students shall pay the tuition fee for undergraduate program to their home university, and come to CM_NCKU as exchange student (waived tuition). After, entering the Master program officially, the participating student shall pay the tuition fee for the Master's program to the host university but will be entitled and eligible to apply the scholarships for international students.
3. The host university under this program will accept a maximum of five students yearly. However, more students may be accepted, if necessary, based on discussions between both universities.
4. Program students are responsible for travel, room and board, required health insurance, and other incidental expenses consistent with the practices and regulations for the host university.

Article 5: Admission criteria and the host university's right of rejection

1. Participating students seeking admission to the host university under the terms of this agreement shall meet the admission requirements of the host university.
2. Each university reserves the right to reject candidates, in which case further candidates may be proposed.
3. The universities will provide each other with adequate information on the performance of participating students.

Article 6: Requirements for a Master degree candidate

1. Participating students shall get enrolled for a Master program for at least 1 years at the host university.
2. By the end of the 2nd year of the Master program, or when all degree requirements at the host university have been fulfilled, the Master degree will be awarded by the host university.
3. An advisory committee consisting of multiple faculty members from both universities shall be appointed to each student to provide supervision on the study and research. A major supervisor shall be appointed from the committee members in the host university to oversee the progress of Master degree research.

Article 7: Implementation of Program

1. Regulations regarding the admission, credit accreditation, organization of an advisory committee, and conferment of a degree shall be decided by each university and subjected to mutual consent.
2. Both institutions agree that all financial arrangements shall be determined on the basis of specific projects and activities, and will depend on the availability of funds.

3. The Agreement shall become effective for a period of 5 years upon the date of signature by the representatives of the two institutions, and shall be renewed by mutual consent, if proposed by either university.
4. If this Agreement is executed more than one language, the English version shall control in the event of inconsistency in meaning or interpretation of terms.

Agreement on Dual Master's Degree Program
between
College of Medicine, National Cheng Kung University
and
Faculty of Medicine, Udayana University

Preamble

In accordance with the mutual desire to foster cooperation between College of Medicine, National Cheng Kung University ("CM_NCKU") and Faculty of Medicine, Udayana University ("FK_UNUD"), and in order to promote research collaboration as well as to explore the Dual Master's Degree Program ("Program"), which may include faculty exchange, and student exchange, the two institutions hereby agree with the following terms under this agreement.

Article 1: Definitions

1. "Home University" shall mean the university in which the students are originally enrolled.
2. "Host University" shall mean the university that has agreed to receive the Program students from the home university.

Article 2: Overview

Successful Program students will be awarded a Master's degree by the home university, FK_UNUD, and a Master's degree by the host university, CM_NCKU. The Program candidates are enrolled as students in a Master program at the home university and, in the 1st year, through proper application procedure, they could get admitted by a Master program offered by the host university for a study period of minimum 1 year. When all degree requirements at the home university and the host university have been fulfilled, a Master's degree will be awarded by each institution individually.

Article 3: Requirements for a candidate student

1. Participating students must be a full-time enrolled students in Master program at the home university.
2. Participating students shall spend at least 12 months at the home university.
3. The home university will pass their applicants' data to the host university. Student will follow the host university admission procedures.

Article 4: Tuition, Fees, and Number of students

1. Each university will endeavour to ensure that outgoing students are properly prepared for their overseas experience in academic matters and appropriated matters of health, language, local custom etc.
2. Program students shall pay tuition to the host university while studying in FK_UNUD. When studying at CM_NCKU, students will need to pay the host university tuition. They will follow the rules and be qualified for all the applicable scholarships or benefits as regular full-time students at the host university.
3. The host university under this program will accept a maximum of two students yearly. However, more students may be accepted, if necessary, based on discussions between both universities.

4. Program students are responsible for travel, room and board, required health insurance, and other incidental expenses consistent with the practices and regulations for the host university.

Article 5: Admission criteria and the host university's right of rejection

1. Participating students seeking admission to the host university under the terms of this agreement shall meet the admission requirements of the host university.
2. Each university reserves the right to reject candidates, in which case further candidates may be proposed.
3. The universities will provide each other with adequate information on the performance of participating students.

Article 6: Requirements for a Master degree candidate

1. Participating students shall spend at least 12 months for a Master degree program at the host university.
2. An advisory committee consisting of multiple faculty members from both universities shall be appointed to each student to provide supervision on the study and research. A major supervisor shall be selected from the committee members of each university. The program shall provide joint supervision on study and research of the students, and joint publication shall be produced from the master thesis.
3. Credits obtained at the host university can be considered for accreditation at the home university, and credits obtained at home university can be considered for accreditation at the host university.
4. The home university shall award a Master's degree, when the student has fulfilled the requirements of the home and the host university. The host university shall award another Master's degree, when the student has fulfilled the requirements of the host and the home university.
5. Student's home university shall approve the extension of enrollment, if necessary.

Article 7: Implementation of Program

1. Regulations regarding the admission, credit accreditation, organization of an advisory committee, and conferment of a degree shall be decided by each university and subjected to mutual consent.
2. Both institutions agree that all financial arrangements shall be determined on the basis of specific projects and activities, and will depend on the availability of funds.
3. The Agreement shall become effective for a period of 5 years upon the date of signature by the representatives of the two institutions, and shall be renewed by mutual consent, if proposed by either university.
4. If this Agreement is executed more than one language, the English version shall control in the event of inconsistency in meaning or interpretation of terms.

Agreement on Dual Master's / Ph. D Degree Program
between
College of Medicine, National Cheng Kung University
and
Faculty of Medicine, Udayana University

Preamble

In accordance with the mutual desire to foster cooperation between College of Medicine, National Cheng Kung University (CM_NCKU) and Faculty of Medicine, Udayana University ("FK_UNUD"), and in order to promote research collaboration as well as to explore the Dual Master's / Ph. D Degree Program ("Program") degree program, which may include faculty exchange, and student exchange, the two institutions hereby agree with the following terms under this agreement.

Article 1: Definitions

1. "Home University" shall mean the university in which the students are originally enrolled.
2. "Host University" shall mean the university that has agreed to receive the Program students from the home university.

Article 2: Overview

Successful Program students will be awarded a Master's degree by the home university, FK_UNUD, and a Ph.D. degree by the host university, CM_NCKU. The Program candidates are enrolled students in a Master program at the home university for at least 1 year, through proper application procedures, they could get admitted to a master program offered by the host university. Student must return to home institution to receive the master degree before coming back to continue directly the PhD degree. The study period of this joint program would be of 2-7 years. When all relevant degree requirements of host institution is completed, a Ph.D. degree will be awarded.

Article 3: Requirements for a candidate student

1. Participating students must be a full-time enrolled students in a Master program at the home university.
2. Participating students shall spend at least one year in the Master program and complete the credit hours and specific courses required to earn the Master degree at the home university. Credits obtained at the host university can be considered for accreditation at the home university. Upon completing the specified courses and fulfilling total credit hours requirements, successful students will be awarded a Master degree from the home university, usually at the end of the 2nd year. The graduation requirement for the Master degree is decided by the home university.
3. The home university will pass the applicants' basic data to the host university, in order for the host university to continue handle necessary admission procedures.

Article 4: Tuition, Fees, and Number of students

1. Each university will endeavour to ensure that outgoing students are properly prepared for their overseas experience in academic matters and appropriated matters of health, language, local custom etc.

2. Participating students shall pay the tuition fee to the institution where they are resident and be exempt from paying tuition to the other institution. The students will be entitled to apply for a scholarship in accordance with the general scholarship policy for international degree students of the host university.
3. The host university under this program will accept a maximum of two students yearly. However, more students may be accepted, if necessary, based on discussions between both universities.
4. Program students are responsible for travel, room and board, required health insurance, and other incidental expenses consistent with the practices and regulations of the host university.

Article 5: Admission criteria and the host university's right of rejection

1. Participating students seeking admission to the host university under the terms of this agreement shall meet the admission requirements of the host university.
2. Each university reserves the right to reject candidates, in which case further candidates may be proposed.
3. The universities will provide each other with adequate information on the performance of participating students.

Article 6: Requirements for Ph. D degree candidates

1. Participating students shall get enrolled for a Ph. D degree program for at least 2 years at the host university.
2. An advisory committee consisting of multiple faculty members from both universities shall be appointed to each student to provide supervision on the study and research. 3. Credits obtained at home university can be considered for accreditation at the host university.

1. “Home University” shall mean the university in which the students are originally enrolled.
2. “Host University” shall mean the university that has agreed to receive the Program students from the home university.

Article 2: Overview

Successful Program students will be awarded a Ph.D degree by the home university, “FK_UNUD”, and a Ph.D degree by the host university, CM_NCKU”, in a minimum of four years in total. The candidate students are enrolled students in a Ph. D program at the home university and through proper application procedures, they could get admitted into a Ph.D program offered by the host university. When all degree requirements of both universities have been fulfilled, dual Ph.D degrees will be awarded by the home university and the host university.

Article 3: Requirements for a candidate student

1. Participating students must be full-time enrolled students in Ph.D program at the home university.
2. Participating students shall spend at least one year at the home university, and at least one year at the host university.
3. The home university will pass their applicants’ data and application materials to the host university in order for the host university to handle necessary admission procedures.

Article 4: Tuition, Fees, and Number of students

1. Each university will endeavour to ensure that outgoing students are properly prepared for their overseas experience in academic matters and appropriated matters of health, language, local custom etc.
2. Program students shall pay tuition to the host university and shall be exempt from paying tuition to the home university under this Program. They will be entitled to apply for applicable scholarships or benefits as regular full-time students at the host university.
3. The host university under this program will accept a maximum of two students yearly. However, more students may be accepted, if necessary, based on discussions between both universities.

The program shall provide joint supervision on study and research of the students, and joint publication shall be produced from the Ph.D thesis.
3. Credits obtained at the host university can be considered for accreditation at the home university, and credits obtained at home university can be considered for accreditation at the host university.
4. The home university shall award a Ph.D. degree, when the student has fulfilled the requirements of the home and the host university. The host university shall award another Ph.D degree, when the student has fulfilled the requirements of the host and the home university.
5. Student's home university shall approve the extension of enrollment to maximum of 7 years, if necessary.

Article 7: Implementation of Program

1. Regulations regarding the admission, credit accreditation, organization of an advisory committee, and conferment of a degree shall be decided by each university and subjected to mutual consent.
2. Both institutions agree that all financial arrangements shall be determined on the basis of specific projects and activities, and will depend on the availability of funds.
3. The Agreement shall become effective for a period of 5 years upon the date of signature by the representatives of the two institutions, and shall be renewed by mutual consent, if proposed by either institution.
4. If this Agreement is executed more than one language, the English version shall control in the event of inconsistency in meaning or interpretation of terms.
